### A BRIEF PROFILE OF TKA COMPANY LIMITED

Preparation of Asset Management Policies: This involves the preparation of a number of policies and procedures for an organization, related to the management of their assets. These policies include: Assets acquisition and disposal; asset depreciation, asset

capitalisation, asset labeling, asset recording and tracking, and related policies.

**Property Development:** TKA carries out feasibility studies for real estate projects, putting together development packages, overseeing project realization, and managing property development schemes, including construction. These also include schemes related to land use planning and land surveying.

Property Management and Land Administration: TKA engages in managing real estate assets in various senses including the securing of title deeds; surveying, arranging leases; securing and managing property income such as rent; maintaining property; arranging sales and transfers; dealing with tenants; estate agency, advice on the optimum use of property; conversions, managing moving into or out of property, furnishing, drapery, managing taxes and charges on property, border reinstatement, and so on.

#### **Legal Status**


